## From the President

As we move into the next few months we will be focusing on our Independence Anniversary celebrations, Christmas programs and then in January for our annual general meeting.

Our plans for Independence celebrations are well on the way and we are expecting the turn out to exceed the numbers we had at each function last year. The events are listed in a separate article and I invite you to contact any member of the Executive should you require any other information.

At this time of the year the Association usually stages events to recognize persons in the community. We recognize our young people who are doing well for themselves by moving on to higher institutions of learning or have graduated. For those of you who assisted in cleaning up the area we used, a hearty thank to you as your work enabled us to get back the deposit made to the St. Lawrence Park. Four members of the Constitutional Review Commission visited Canada where they held sessions with Vincentians in several

cities to get their views on the revision of the St. Vincent and the Grenadines Constitution. The electricity black-out marred their visit to Toronto but overall the rescheduled meeting provided a forum for useful contributions from Torontonians. Consul General E. B. John is attempting to coordinate another session with the help of Vincy groups in Toronto so that more of us can come out to participate in making a presentation to the government. A member of our community has provided his input in an article found on page 6 of this publication.

Please feel free to write to us and share articles with other readers. ## CONSTITUTIONAL REFORM: POLITICS, ILLUSION AND THE MANAGEMENT OF THE VINCENTIAN STATE:

The Government of St. Vincent and the Grenadines has embarked on a bold path of Constitutional reform. To this end a Constitutional Review commission has been established with a mandate to canvass the ideas of Vincentians both at home and abroad.

The efforts and initiatives at constitutional reform are certainly in the noblest of traditions within any political system. A constitution is a mechanism for the expression of the collective will of a people. It establishes the ideals and structure of a state. It is a document that reflects the past and maps out the future of a people. The constitutional commission will no doubt take back to St. Vincent a wealth of proposals, ideas and schemes for reforming the constitution.

But as the debate rages on, it is important that our ideas and proposals for reform are grounded on the basic needs of the Vincentian people and the limitations of the Vincentian state. In other words, our proposals for reforms should consider the practical needs of the Vincentian people and their right to good governance, and economic prosperity.

One should take a serious look at all proposals that tend to increase "politics" in the country. Such proposals include the introduction of a bi-cameral house with a separate senate as well as proposals for proportionate representation. It is questionable whether these systems are necessary or suitable to a micro-state with a small population and tax base. The natural results of any endorsement of a bi-cameral house and proportionate representation are a proliferation of politics and politicians, with a concomitant increase in the costs of governance. This begs the question: How many political bodies are necessary to govern a country with a small population? This author contends that the country could be adequately governed by a small group of elected representatives, convening in one central assembly. To this end, this author proposes that the current Parliament should be reduced by half.

The above observations are mindful of the political culture in St. Vincent and in the wider Caribbean, where "politics" is as big as a continent. There is an apparent disconnect between politics and the size of the state, be it measured in economic or geographical terms. The hysteria and messianic fervor conjured up by Vincentian and Caribbean politicians far outweigh or justify the actual reality of the Vincentian people and state. For instance, the tax base and available resources to governments are such that there are marginal benefits between governments. To put it bluntly: it matters little what government is in power. When the dust settles, rhetoric and politics always fall short of economic development. A cursory analysis of the achievements of Vincentian governments reveals that the pace of development is at best equal under each administration.

The advancement of proposals to reduce the political organs of state is not an attack on the noble tradition of politics within St. Vincent and the Grenadines. It is recognized that our history by its interaction with all the major political systems creates a cosmopolitan but illusionary view of politics and governance as it relates to the state. If serious consideration is being given to the abolition of the British Monarch as head of State, we should also consider our political philosophy, mores and psyche, which are more in keeping with a large Westminster democracy, than a state in the eastern Caribbean, with limitations of geography and resources.

This suggests that the path of constitutional reform should be modeled on the needs of the state in a truly indigenous fashion. What then should drive reform of the constitution? It is my submission that reforms must be closely knitted to the economic realities of the state at home and its interaction with the Caribbean and wider interventional community. At home the thrust should be the reduction of politics by reducing the size of the current parliament in favour of a smaller central assembly. Supported by local councils with real powers to cater to the needs of the people. Cabinet should be a bi-partisan body elected by the central assembly.

The Prime Minister will also be elected by the central assembly and could be removed by the central assembly. Such a scheme ensures the participation of opposing political parties in the management of the state. Conceptually, in this type of system politicians from parties who did not gain a majority at the polls could be elected to cabinet. This ensures the participation of people with opposing political views in the management of the state. Moreover, it diminishes political tensions within the country and advances the management of the state, rather than the promotion of self-serving and narrow political agendas.

Proposals for the curtailment of politics should be supported by ideas for the effective management of the state. In the Westminster political system, there is an inherent tension between political management and the organs, the bureaucracy that administers policy. In our system of government in St. Vincent and the Grenadines, there have been historical tensions between the bureaucracy and the political masters in parliament. The independent of the bureaucracy or public service is often compromised by the whims of political parties for narrow political gains, which have little or nothing to do with progressive management for the common good of the people. It is this author's opinion that the stability of the public service should be cornerstone of constitutional reform in the context of economic development.

To this end careful attention should be given to the reform of what is referred to as the "executive". Under the current system, the prime minister wields tremendous power over the appointment of the secretary to Cabinet, the permanent secretaries, heads of departments of Governments. This system does not augur well for good management and for the development of a professional public service with an unselfish devotion to the management of the Vincentian state. A critical unit in this scheme is the public Service Commission. At present, the members of the commission are appointed with the advice of the Prime Minister. The end result of this system is the politicization of the public service.

It is this author's contention that the public service commission should be appointed by a bi-partisan committee of parliament, acting on the recommendations of key sectors in the economy, such as business, agriculture, education and the professions. The commission would then have powers to reassign, and discipline public servants in the interest of the management of the state.

As the reform process moves ahead, this author challenges Vincentians to review the role of politics in the state. Is Politics

contributing to waste and inefficiencies? Should the country place more emphasis on management systems? Is the current format of the Westminster political system compatible to a small state? It is my submission that more bi-partisan structures in the constitution, coupled with an emphasis on management as it relates to people and resources without political underpinnings could enhance progress and development in St. Vincent and the Grenadines.
