AMERICAN TARIFFS AFFECT SHIPPING TO THE CARIBBEAN

Tropical Shipping President and CEO Tim Martin recently testified before the U.S. Trade Representative (USTR) that the proposed tariffs would severely affect American-owned shipping companies as well as U.S. exporters and Caribbean businesses that ship with Tropical. The proposed tariffs include a flat \$1 million port fee on Chinese-built vessels entering U.S. ports. “The U.S. shipping industry serving the Caribbean cannot absorb the additional costs of the proposed port fees, which would have significant economic consequences,” Martin testified. “instead of strengthening American competitiveness, these port fees would push American-owned carriers like Tropical out of business.”

Tropical Shipping operates out of the Port of Palm Beach, Fla., and nine of its 19 vessels were built in China up to 25 years ago. Martin asked the USTR to exempt American-owned and headquartered vessel operators from proposed fees and to apply the tariffs on future ships built in China, but not on fleets that are already in service.

Tropical transports about half of all goods imported to the Caribbean, and Central and South America – poultry, agriculture products, groceries, building materials, medicine, and hurricane relief supplies. The proposed fees would force Tropical Shipping to double its freight rates, causing its Caribbean customers to buy from outside the U.S. at a higher cost.

VINCENTIANS ARE GEARING UP FOR GENERAL ELECTIONS

The election fever is ramping up among the people of St. Vincent and the Grenadines as both major parties, the ruling United Labour Party (ULP) and the main opposition party, the New Democratic Party (NDP) are completing their slate of candidates for the polls which are constitutionally due by February 2026, but many folks feel that the bell will be rung months before that time.

In the current parliament, the ULP holds 9 of the 15 constituencies while the NDP has 6. The next election, when ever it is called, will see a number of new candidates as some former contestants from the two major parties have indicated that they will not be offering themselves again. The ULP is currently celebrating its 24 years anniversary in government and is looking to hit a "Six", meaning, "Six-In-A-Row".

SVG GOVERNMENT ACQUIRES BALLICEAUX

On March 4, 2025, the quiet publication of a second declaration in the Government Gazette heralded a revolutionary act of nationalism, historical reclamation and justice: The Government of Saint Vincent and the Grenadines had acquired the island of Balliceaux, and returned that sacred site of tragedy and triumph to the Vincentian people.

This is no small feat. From the date of the exile and imprisonment of Garifuna warriors and their families on Balliceaux almost 230 years ago, the island has been a possession of foreigners. In the four and a half decades since Saint Vincent and the Grenadines reclaimed our independence from the British, Balliceaux has been a stubbornly visceral reminder of the powerful lingering legacies of colonial exploitation and injustice. Our persistent calls for reparatory justice for the genocide committed against our indigenous people are anchored in the colonial killing of almost 2,500 Garifuna people on Balliceaux.

DR. KISHORE SHALLOW RE-ELECTED AS PRESIDENT OF CWI



Vincentian, Dr. Kishore Shallow has recently been elected unopposed as president of Cricket West Indies, the governing body for cricket in the West Indies. This is his second consecutive term and he is also a director of the International Cricket Council (ICC), the governing body for world cricket. He has served as president since February 2023. Under his leadership, Cricket West Indies cohosted the ICC Men's T20 World Cup 2024 with the United States.

Dr Shallow urged Caribbean leaders to take heed of what he described as a blueprint for economic revitalization through sport. "Our economies have been overly reliant on traditional industries for far too long. This World Cup has proven that sport—cricket in particular—is a powerful and underutilized economic engine," he said.

As the region prepares to commemorate the 50th anniversary of the West Indies' first Cricket World Cup triumph in 1975, Shallow believes the legacy of the 2024 tournament will inspire a new generation—not just of players, but of sports administrators, marketers, and entrepreneurs.

IMMIGRATION MATTERS

Is Canadian Citizenship for Sale? Understanding Investment-Based Immigration

Canada may not be for sale, but is Canadian citizenship for sale? You may have heard the term “Citizenship by Investment”. This implies that foreign nationals can obtain citizenship of a country by making a significant investment into that country’s economy. While Canada does not offer a “Citizenship by Investment” program, wealthy individuals can leverage their resources to apply for **permanent residence (PR)** status through business class immigration programs such as the **Start-up Visa Program** or various **Provincial Nominee Programs (PNPs)**.

Provided that a foreign national is not eligible to obtain Canadian citizenship by descent, s/he must first apply for and be granted permanent resident (PR) status. This requirement also applies to an investor or entrepreneur. Acquiring PR status is only the first step - **Canadian citizenship must still be earned**, requiring an adult applicant to demonstrate that s/he has at least 3 years (1095 days) of physical presence in Canada within the 5-year period preceding the date of their application, among other requirements. Wealthy investors and entrepreneurs are thus treated like “regular” foreign nationals when it comes to acquiring citizenship and thus cannot jump the queue.

Investors and entrepreneurs with substantial financial resources do have an advantage over “regular” foreign nationals to potentially apply for and obtain permanent resident status under business immigration streams/programs.

The Start-up Visa program and the Provincial Nominee Programs (PNPs) usually require an investor or entrepreneur (as the principal applicant) to have a substantial net worth and funds to either start-up, purchase or invest in a business venture.

The Start-up Visa Program is geared towards innovative entrepreneurs who have a minimum investment of Cdn\$75,000.00 and possess the skills and potential to build a business in Canada (excluding Quebec) which could compete on a global scale and also create jobs for Canadians. Quebec runs its own Business Immigration Program for Investors and Entrepreneurs seeking to contribute towards Quebec's economy. With the exception of Quebec and Nunavut, Provincial Nominee Programs (PNPs) permit Canada's provinces and territories to formulate their own streams or pathways with rigorous eligibility criteria and timelines. Pathways allow investors and entrepreneurs to immigrate to a province or territory as temporary residents with the potential of later applying for permanent resident status once they have successfully started their business venture.

Some PNP's target investors, entrepreneurs and also skilled workers. Manitoba has a Business Investor Stream with two pathways (Entrepreneur and Farm Investor). Entrepreneur Immigration (EI) is a way for international entrepreneurs wishing to immigrate to British Columbia (BC.), via BC's Provincial Nominee Program (BC PNP), to set up a business that support innovation and economic growth in BC. Interested candidates seeking to immigrate as an investor or entrepreneur should assess the various PNPs requirements to their own qualifications and financial means.

Although it may appear that wealthy investors and entrepreneurs have the privilege of using their capital towards securing permanent resident status in Canada, they still have to transition towards Canadian citizenship like other immigrants. Money talks but it does not shout, citizenship.


