## **ASSOCIATION NEWS**

#### **Annual General Meeting**

The forty-first Annual General Meeting of the Association was held on Sunday, January 29, 2010 during which a report for the previous year was presented and a new executive was elected to run the affairs of the Association for a full year ending on January 30, 2011.

Special guest at the meeting was Consul General Mr. Steve O. Phillips who encouraged members to work together for the benefit of the Association and the SVG community as a whole. Mr. Phillips took time out to draw attention to the high number of SVG nationals in Toronto who are filing for refugee status and noted that it was of grave concern to the government of St. Vincent and the Grenadines. He cautioned that it might not be too far off that the Canadian government puts legislation in place for SVG nationals to join the long list of nationals from other countries to have to apply for visas to visit Canada.

Following the AGM Cordel Telfer has since been elected as Assistant Treasurer, the sole elected position that was not filled at the AGM. Since then, Carmen Parsons has also been added to the executive as a Nominated Member. Both Cordel and Carmen have served on previous executives. See page 1 for a list of all executive members.

#### **YOUR SECURIITY**

#### Identity Theft - It Could Happen to You!

When an imposter steals your name, your Social Insurance Number (SIN), your credit card number or some other piece of your personal information for their use, without your knowledge – IT'S A CRIME, PLAIN AND SIMPLE.

Maybe you never opened that account or ordered an additional card, but someone else did, someone who used your name and personal information to commit fraud.

Some of the signs your identity might have been stolen:

- a) Bills and statements don't arrive when they are supposed to they may have been stolen from the mailbox or someone has changed the mailing address.
- b) You receive calls from collection agencies or creditors for an account you don't have or that is up-to-date. Someone may have opened a new account in your name, or added charges to an account without your knowledge or permission.
- c) Financial account statements show withdrawals or transfers you didn't have.
- d) A creditor calls to say you've been approved or denied credit that you haven't applied for. Or, you get credit card statements for accounts you don't have.
- e) You apply for credit and are turned down for reasons that do not match your understanding of your financial position.

#### What To Do:

- Call your financial institutions and the police;
- Put a fraud alert on your credit report;
- Contact Canada Post if your mail is missing:
- Keep records of steps taken to clear your name and re-establish your credit;
- To replace ID cards like health, driver's licence, SIN call 1-800-Canada.

#### **About Your Debit Card**

Debit card skinning is the method that fraudsters use to copy your magnetic stripe information and PIN which is then used to reproduce a counterfeit card and seal money from your bank account. Fraudsters use hidden equipment such as pinhole cameras and card reading devices to obtain your magnetic stripe info.

A chip card is a new generation of payment card technology that will put the power of a computer onto the debit card and provide increased protection against debit card skimming.

The Harmonized Sales Tax on July 1, 2010 will affect the price on a number of items. Please see what you can save on NOW. See FAQ on Page 7. Chip cards and terminals have started to roll out across Canada and will continue to enter the marketplace over the next several years to be completed in about 2015.

Cardholders are protected and will not suffer financial losses due to circumstances beyond their control if they are victims of debit card fraud.

The type of information stored on your magnetic stripe is payment related information that allows the debit transaction to be authorized and processed, such as the debit card number, the financial institution code or country code. If captured, fraudsters primarily use the payment information on your magnetic stripe to make a counterfeit card and steal money, not your identity. With the transition to chip, the same information will now be stored within the chip, which is protected by multiple layers of security, making it extremely difficult to copy the information and make a counterfeit card.

## St Vincent minister praises work of Cuban medical brigade

HAVANA, Cuba -- (ACN) Douglas Slater, Minister of Public Health from St Vincent and the Grenadines on Friday praised the scientific level of the Cuban medical team now working in his country in the Vida a la Vida project for the disabled.

While addressing participants in the parliamentary session, Slater spoke about the scientific, psychosocial and clinical studies carried out since March 1 by 38 Cuban voluntary workers for the benefit of the disabled in the neighbouring nation. The official highlighted that this study has been favourably received by the population and its significance for the devising of governmental strategies for social attention, the Cuban Foreign Ministry's web site reports.

St Vincent and the Grenadines is the first country in the Caribbean to receive this project, in the results of which the University of the West Indies is very much interested.

Slater said that the program has been approved by the Commission of Ethics in his country, an essential aspect before implementing a program of this magnitude.

Cuban specialists have already made studies on the disabled in Venezuela and Nicaragua, and are currently carrying them out in Ecuador and Bolivia, under the auspices of the Bolivarian Alliance for the Americas (ALBA).

## Launch date of new Caribbean inter-island ferry service to be announced soon

ST GEORGE'S, Grenada -- With the gradual resolution to a number of logistical issues, the date for the launch of the Caribbean's new inter-island ferry service, will soon be announced.

In a statement on Wednesday, Benjamin Ross, CEO of the Grenada-based owners and operators of the service, BEDY Ocean Lines, said his company has been making significant progress with a number of logistical matters, which had accounted for earlier delays in the start of the service, and is now looking forward to bringing the people of the Eastern Caribbean and beyond, a safe and reliable mode of transportation that provides all their travel solutions.

In the company statement, Ross apologised to the people of the region for the unavoidable delay, and reiterated that the service was "still very much on stream".

The new ferry service, which will see inter-island passengers paying one-third of the current airfare for travel to the islands by air, will be offered to residents of Barbados, St Vincent, St Lucia, Trinidad and Grenada.

Initially, the company's two vessels, which are passenger speed boats, will each have a seating capacity ranging from 260 to 300. One of the vessels will make St Vincent its home and will service the St Vincent to Barbados and St Lucia routes, while the second ferry will be based in Grenada and will service the Grenada to Trinidad and Barbados route.

## Haiti earthquake provides opportunity for integration into CARICOM

KINGSTON, Jamaica (JIS) -- Former Prime Minister of Jamaica and Caribbean Community (CARICOM) Special Representative to Haiti, PJ Patterson, said the devastation caused by the Haiti earthquake provides the opportunity for the full integration of the country into the Caribbean Community drawing on the best of its history and culture.

He noted that while Haiti had not yet subscribed to the Caribbean Single Market and Economy (CSME), President Rene Preval has repeatedly indicated that Haiti's future model of development must be consistent with integration into CARICOM.

"Future policy and planning for the country must therefore take this into account and be geared towards helping it to become a full beneficial member of the CSME," he stated at a public forum in Castries, St. Lucia on Tuesday, March 9, on route to the meeting of Inter-Sessional Heads of Government in Dominica from March 11 to 12.

The former Prime Minister maintained throughout his address that while CARICOM was there to assist and advise, Haiti must be primarily responsible for its own development plan. Regarding the way forward as supported by CARICOM, Haiti has already indicated an initial focus on agriculture, light manufacturing and services.

Hence, the rebuilding of the economic and social infrastructure, including substantial housing, should be seen as an important part of the way forward given the country's potential employment capacity. In addition, tourism is seen as a key driver in the recovery process, given its linkages with agriculture, arts, crafts and culture.

Patterson stressed the importance of planning small business development within the context of climate change, sustainability and the creativity of the Haitian people, utilising the depth and diversity of the CARICOM cultural profile. He said that the private sector of Haiti and its CARICOM arm should gear up and equip itself for much of the work.

The forum in St Lucia was organised by the co-ordinating committee of civil society representatives, which was formed to help ensure a more cohesive response to the national effort aimed at assisting the people of Haiti. Patterson praised the initiative, noting that St Lucia and Dominica were uniquely poised to advance the rebuilding process in Haiti.

He said that both countries had the strong bond of language and a shared colonial history that brings them closer to Haiti than most other countries of the region. "This makes your nations ideally suited to assume a leadership role as CARICOM establishes its physical presence in Haiti to assist the redevelopment," he stated.

#### BENEFITS OF PRE-ARRANGING & PRE-FUNDING

Planning ahead is a part of our daily lives. We plan for holidays, special occasions and quite a number of things, some of which may never happen. In the prime of our lives we plan for the things we enjoy and this has become an integral part of Canadian culture.

The terms pre-arranging and pre-funding are usually associated with death and funeral and even though death is the only certain thing that will happen in our lives, many of us are afraid to deal with the subject much more going ahead with making arrangements for the inevitable.

Since we know that one day we will die then the sensible thing to do would be to plan for that day by putting as much in place as is possible since we do not know when death will come.

A summary of the advantages and benefits or pre-planning your cemetery and funeral products and services include:

- a) Peace of Mind Decisions are made together in cases of couples and at times with other family members. This gives the peace of mind because the decision is not made alone nor left to the survivors; In case of individuals, it takes the strain off the surviving relatives who may not know how the deceased would have preferred to have his or her departure felt;

- g) To Guarantee Price Against Inflation or Loss of Income Purchasing early guarantees the price from inflation, changes in taxation and at a time when you can better afford it;

- h) Relatives Are Aware of Your Final Wishes Having gone through the process of making your final wishes, it is very unlikely that your loved ones will change them at the time of your passing;
- Available Convenient Terms to Suit Any Budget

   Most cemetery and funeral providers have convenient payment terms over a period of years.

   When plans are not in place, the total cost of products and services quite often overburdens the surviving relatives left to take care of things;
- Better Choice Selection With a clear mind and no rush to make decisions you are better able to make sound and long lasting choices and there are more available options;
- k) Decisions Can Be Changed or Altered As we go through life we make changes to the things we have. Changes can be made to products and services prior to their use;
- Transferability In some cases, after a period of time one may decide to move to another area of the country. In that case, the products can be transferred to the new location providing the cemetery provider has property in that area. The product and services can also be transferred to a loved one or another person;
- m) **HST Increases Costs** Currently, the only tax on cemetery and funeral services is the 5% GST. As of July 1, 2010 when the Harmonized Sales Tax becomes effective the new tax will be 13%.

#### **Sponsoring your Family Members**

Do you have family members living inside or outside Canada whom you would like to sponsor to become a permanent resident? If so, take these necessary precautions and suggestions prior to submitting an application package to Citizenship and Immigration Canada (CIC).

First ensure that you meet the eligibility criteria as a sponsor. If you have any bars to sponsoring (i.e.: default in prior undertaking, default in court ordered support payments, pending bankruptcy proceedings, etc.) rectify them prior to submitting your application to sponsor. Secondly, ensure that the person being sponsored meets CIC's definition of a Family Class member. Thirdly, find out what documentation you and your family member may need to substantiate your case.

You may sponsor spouses and common-law partners who reside in Canada without status through the Spouse or Common-law partner in Canada class category. All other family members residing in Canada without status may submit a Humanitarian and Compassionate application which may be supported by you as a sponsor - this constitutes an undertaking of assistance. If your family member resides outside Canada, you may sponsor him/her under the Family Class category.

If you are sponsoring a spouse, common-law or conjugal partner, you will need to convince the immigration officer that your relationship is genuine and ongoing and thus not entered into for immigration purposes. Be sure to provide comprehensive and persuasive information and documentation such photographs, as records of communication, proof of joint matters, etc.

If you are a father sponsoring a dependent child, it would be beneficial that your name appears on the child's birth certificate as the father. This would help to avert any added costs of paternal DNA testing. If sponsoring other family members (parents, grandparents, orphans or other relatives), you should provide evidence to prove your relationship with each other and which suggests that the relationship has been continuous.

Filling out multiple application forms, each of which may range in length from one to six pages, can be quite intimidating. If you hire someone to assist you, make sure that he/she is a competent authorized representative. Authorized representatives include Certified Canadian Immigration Consultants (CCIC) who are members of the Canadian Society of Immigration Consultants (CSIC) and lawyers/notaries who are members of a provincial law society. The money spent in doing so may avert a more costly Appeal process and wasted time in being united in Canada.

#### **Frequently Asked Questions About the HST**

#### What is a Harmonized Sales Tax?

Ontario plans a major tax reform that will combine both the provincial and federal sales tax on products and services. The combined tax of five per cent GST and eight per cent Ontario sales tax won't change the price on most items. But many items that used to be exempt from sales tax will no longer be so.

#### What is no longer PST exempt?

Consumers are most likely to notice an increase in the price of gasoline and heating fuels. Electricity will no longer be exempt from provincial sales tax, nor will tobacco, personal services like haircuts, membership fees for clubs and gyms, newspapers and magazines, taxi fares, cemetery and funeral and the professional services of lawyers, architects and accountants. Real estate commissions will also be taxed.

#### Will anything remain exempt?

Not a lot. Children's clothing and footwear, children's car seats and car booster seats, books, diapers and feminine hygiene products will remain exempt from the provincial portion of the single sales tax. Basic groceries, rent, condo fees, prescription drugs, and medical devices remain exempt from both PST and GST. Purchase of resale homes will remain exempt from PST, although real estate transaction fees will be taxed.

#### Why is Ontario doing this?

The province says implementation of the single sales tax would bring Ontario into line with "what is viewed as the most efficient form of sales taxation around the world." The finance ministry says the single sales tax would reduce the cost of goods that Ontario exports, making the province more competitive and boosting a sector of the economy that has been particularly hard hit by the economic downturn.

At the moment, businesses may not deduct the PST from the cost of materials and other products they buy; instead, they pass the cost along to consumers. But under harmonization, businesses may claim tax credits for those purchases, which some estimates suggest could save them \$3-billion a year.

The Ontario Chamber of Commerce believes a fully blended system would cost consumers approximately \$905 million in additional sales taxes per year, while the GST and PST bill for companies would fall by \$1.6 billion annually.

The Canadian Federation of Independent Businesses says harmonization will save business \$100 million a year in reduced red tape.

Businesses will save a further \$500-million a year on the costs of administering a single tax instead of two, according to the budget documents.

#### Are all businesses on side?

Contractors, developers and homebuilders oppose the blending. Ontario's Building Industry and Land Development Association estimates that a blended tax would add more than \$46,000 to the price of a \$580,000 new home in Toronto.

#### Will household expenses rise?

Yes, although the province says it will offer \$10.6 billion worth of tax relief over the next three years:

- Cash payments of up to \$1,000 for in 2010 and 2011 for families earning less than \$160,000 a year.
- A new permanent \$260 refundable sales tax credit for low to middle-income adults and children.
- An enhanced refundable property tax credit for low and middle-income homeowners and tenants.
- New homes under \$400,000 would be exempt from the new blended tax.
- \$1.1 billion in personal income tax cuts

#### So what's the problem?

The provincial NDP says the single sales tax would leave families "feeling the pinch" from having to spend more on a range of goods at a time that many are already struggling to deal with job losses. The Conservatives, while ideologically in favour of harmonizing, say this is no time to be raising taxes.

The Ontario Real Estate Association says merging the taxes will add more than \$2,000 to the cost of a real estate transaction, hurting the resale home market and prolonging the housing industry's recovery from the economic doldrums.

#### Is Ontario alone in this?

All the Atlantic provinces except Prince Edward Island have a harmonized sales tax.

#### When does the new tax begin?

July 1, 2010.

#### Timmy crops launched in SVG



SVG Chamber of Commerce and representatives of other organizations in support of the Timmy Crops initiative.

In a matter of months, Vincentians will be able to feast on agro products harvested from the fields of Timmy Crops.

Timmy Crops is the newest business venture undertaken by the Intermediate High School, in collaboration with the St. Vincent and the Grenadines Chamber of Commerce and their newly launched Schools Garden Project.

The Intermediate High School is the first school on this project.

Executive Director of the SVG CIC Shafia London indicated at a school assembly to launch the project last Friday that the students that make up Timmy Crops would be responsible for market research, planting and harvesting the produce, marketing and record keeping.

"In the future, we expect that some of the students will be involved in various businesses," London said. "They all stand to benefit from the basic business thinking, business skills and, above all, hands on business experience they will acquire during this project."

London said that the project was started in an effort to reignite the interest of agriculture among Vincentians, especially young people, whom she noted could be motivated to become more involved in the agricultural sector and consider business in agriculture as a viable career option.

Also throwing their support behind the project is the Ministry of Agriculture, which was represented at the launch by Winston George, as well as Jethro Greene of ECTAD, and Philmore Isaacs of IICA.

The men congratulated the Chamber as well as the school for the initiative and promised support from their organizations towards the projects. Villette Browne, Managing Director of Bickles, the project's major sponsor, said that her company was also in full support of the project because they believed in the abilities of the students, and was expecting great things from the school.

She said that the students are being given an opportunity to make a difference and they should make the most of that opportunity.
